PUBLIC LAW NO. 15-80

AN ACT

To appropriate \$540,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2009, for the purpose of funding the T-3 Program Operation, public projects and social programs in the States of Chuuk, Yap, Pohnpei and Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$540,000 is hereby appropriated from
2 the General Fund of the Federated States of Micronesia for the
3 fiscal year ending September 30, 2009, for the purpose of funding
4 the T-3 Program Operation, public projects and social programs in
5 the States of Chuuk, Yap, Pohnpei and Kosrae, and for other
6 purposes. The sum appropriated herein shall be apportioned as
7 follows:

15 Section 2. Allotment and management of funds and lapse date.

16 (1) General Provisions.

17 (a) All funds appropriated by this act shall be
18 allotted, managed, administered and accounted for in accordance
19 with applicable law, including, but not limited to, the Financial
20 Management Act of 1979 and the amended Compact of Free Association
21 between the United States Government and the Government of the
22 Federated States of Micronesia and its related agreements.

23 (b) The allottees shall be responsible for
24 ensuring that these funds, or so much thereof as may be
25 necessary, are used solely for the purpose specified in this act,

1 and that no obligations are incurred in excess of the sum
2 appropriated.

3 (2) Allottees. The allottee of the funds appropriated
4 by this act are as follows:

5 (a) Subsection 1 of Section 1 - the allottee of
6 these funds shall be the President of the Federated States of
7 Micronesia or his designee;

8 (b) Subsection 2 of Section 1 - the allottee of
9 these funds shall be the Governor of Yap State or his designee;

10 (c) Subsection 3 of Section 1 - the allottee of
11 these funds shall be the President of the Federated States of
12 Micronesia or his designee;

13 (d) Subsection 4 of Section 1 - the allottee of
14 these funds shall be the Chuuk State Commission on Improvement
15 Projects;

16 (e) Subsection 5 of Section 1 - the allottee of
17 these funds shall be the President of the Federated States of
18 Micronesia or his designee.

19 (3) Lapse Date. The authority of the allottee to
20 obligate funds appropriated by this act shall not lapse until
21 fully expended.

25 Section 3. This act shall become law upon approval by the

1 President of the Federated States of Micronesia or upon its
2 becoming law without such approval.
