PUBLIC LAW NO. 17-22

AN ACT

To amend Public Law No. 16-43, as amended by Public Laws Nos. 16-48, 16-53, 16-60, 16-65, 16-70, 17-01, and 17-16, by amending section 9 thereof to change the use of funds previously appropriated therein to cover unpaid bills incurred for past general and special elections, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 9 of Public Law No. 16-43, as amended
2 by Public Law No. 16-65, is hereby further amended to read as
3 follows:

4 "Section 9. Capital and Human Resources Development.

5 The sum of \$9,022,185, or so much thereof as may be
6 necessary, is hereby appropriated from the General
7 Fund of the Federated States of Micronesia for the
8 fiscal year ending September 30, 2011, for the
9 following capital improvements, development programs,
10 and projects and human resources development. Of the
11 total amount of funds appropriated herein, \$3,800,000
12 shall be deemed to come from funds available under
13 the amended Compact from the education sector;
14 \$684,126 shall be deemed to come from funds available
15 under the Supplemental Education Grant; \$200,000
16 shall be deemed to come from funds available under
17 the amended Compact from the health sector; and
18 \$635,585 shall be deemed to come from funds available

1 under the amended Compact from the capacity building
2 sector. The sum appropriated by this section shall
3 be apportioned as follows:
