AN ACT

To amend section 1 of Public Law No. 1-118, as amended by Public Law 50. 1-125. No. 1-125, to provide supplemental funding for National Covernment programs during fiscal year 1981 by increasing the amount previously appropriated to \$2,411,200, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. Section 1 of Public Law No. 1-118, as amended by Public
2	Law No. 1-125, is hereby further amended to read as follows:
