AN ACT

To further amend Public Law No. 20-155, as amended by Public Law No. 20-177, by amending sections 4 and 6 thereof, for the purpose of changing the use and allottee of funds previously appropriated therein, to fund public projects and social programs for the people of Pohnpei, and for other purposes.

10	Section 2. Section 6 of Public Law No. 20-155, as amended by
11	Public Law No. 20-177, is hereby further amended to read as
12	follows:
13	"Section 6. Allotment and management of funds and lapse
14	date. All funds appropriated by this act shall be
15	allotted, managed, administered and accounted for in
16	accordance with applicable laws, including, but not
17	limited to, the Financial Management Act of 1979. The
18	allottee shall be responsible for ensuring that these
19	funds, or so much thereof as may be necessary, are used
20	solely for the purpose specified in this act, and that
21	no obligations are incurred in excess of the sum
22	appropriated. The allottee of the funds appropriated
23	under section 2 of this act shall be the Governor of Yap
24	State or his designee; PROVIDED THAT the allottee of
25	funds appropriated under subsection 2(c) of this act

shall be the	Speaker of the Congress of the Federated
States of Mic	ronesia or his designee. The allottee of
funds appropr	iated under section 3 of this act shall be
the Governor	of Kosrae State or his designee. The
allottee of f	unds appropriated under section 4 of this
act shall be	the President of the Federated States of
Micronesia or	his designee; PROVIDED THAT the allottee
of funds appr	opriated under subsections 4(1)(c) of this
act shall be	the Governor of Pohnpei State or his
designee; the	allottee of funds appropriated under
subsections 4	(2)(a) and $4(2)(b)$ of this act shall be the
Pohnpei Trans	portation Authority; the allottee of funds
appropriated	under subsections $4(2)(c)$, $4(2)(d)$ and
4(2)(e) of th	is act shall be the Secretary of the
Department of	Transportation, Communications and
Infrastructur	e or his designee; the allottee of funds
appropriated	under subsections $4(3)(a)$, $4(3)(e)$ and
4(3)(f) of th	is act shall be the Luhken Moanlap of
Kitti; the al	lottee of funds appropriated under
subsection 4(3)(g) of this act shall be the Secretary of
the Departmen	t of Education or his designee. The
allottee of f	unds appropriated under subsection 4(3)(d)
of this act s	hall be the Secretary of the Department of
Resources and	Development or his designee. The allottee
of the funds	appropriated under subsections 5(1), 5(3)

1	and 5(6) of this act shall be the Governor of Chuuk
2	State or his designee; the allottee of the funds
3	appropriated under subsection 5(2) of this act shall be
4	the Mortlocks Island Development Authority (MIDA); the
5	allottee of the funds appropriated under subsection 5(4
6	of this act shall be the Southern Namoneas Development
7	Authority; the allottee of the funds appropriated under
8	subsection 5(5) of this act shall be the Faichuk
9	Development Authority. The authority of the allottee to
10	obligate funds appropriated by this act shall lapse on
11	September 30, 2021."
12	Section 3. This act shall become law upon approval by the
13	President of the Federated States of Micronesia or upon its
14	becoming law without such approval.
