

AN ACT

To amend sections 1 through 7 of Public Law No. 2-21 to appropriate the sum of \$4,243,575 from the General Fund of the Federated States of Micronesia and the sum of \$4,278,000 from the United States Grant Special Fund for the fiscal year ending September 30, 1982, for the operations of the executive branch, legislative branch, National judiciary, public auditor, agencies of the National Government, and for special programs, contributions, grants, subsidies, and refunds of the National Government during fiscal year 1982; to establish employment ceilings; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Sections 1 through 7 of Public Law No. 2-21 are hereby
2 amended to read as follows:

3 "Section 1. Operating expenses of the executive branch. The sum
4 of \$1,130,900, or so much thereof as may be necessary, is hereby
5 appropriated from the General Fund of the Federated States of
6 Micronesia, and the sum of \$3,796,700, or so much thereof as may
7 be necessary, is hereby appropriated from the United States Grant
8 Special Fund for the fiscal year ending September 30, 1982, for
9 the operations of the executive branch of the National Government
10 of the Federated States of Micronesia during fiscal year 1982.

11 The sums appropriated by this section shall be apportioned as
12 follows:

9 Micronesia, and the sum of \$400,000, or so much thereof as may
10 be necessary, is hereby appropriated from the United States Grant
11 Special Fund for the fiscal year ending September 30, 1982, for
12 the operations of the National judiciary of the Federated States
13 of Micronesia during fiscal year 1982. The sums appropriated by
14 this section shall be apportioned as follows:

1 to each of the Departments and offices of the executive branch,
2 legislative and judiciary branches, and to the agencies as provided
3 above, except that the President may transfer up to 12 positions
4 between Departments and offices of the executive branch. This
5 authorization of positions covers all permanent employees and all
6 contract personnel whose employment extends for one year or more
7 (including positions funded from Federal programs). No funds may
8 be expended for unbudgeted positions."

9 Section 2. This act shall become law upon approval by the President
10 of the Federated States of Micronesia or upon its becoming law without such
11 approval.
