

SECOND CONGRESS OF THE FEDERATED STATES OF MICRONESIA

THIRD REGULAR SESSION, 1982

CONGRESSIONAL BILL NO. 2-225

AN ACT

To amend Public Law No. 1-146 appropriating the sum of \$415,900 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1981, for the purpose of funding certain public projects in the State of Ponape, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 1-146 is hereby amended to  
2 read as follows:

3 "Section 1. The sum of \$415,900 or so much thereof as may be  
4 necessary, is hereby appropriated from the General Fund of the  
5 Federated States of Micronesia for the fiscal year ending  
6 September 30, 1981, for the purpose of funding certain public  
7 projects in the State of Ponape. The sum appropriated shall be  
8 apportioned in the following manner:

- 9 (1) Construction of Ponape circumferential
- 10 road . . . . . \$148,900
- 11 (2) Construction of farm roads, small bridges,
- 12 water systems, channels, or small-scale hydro-electric
- 13 plants, or repair of classrooms, or public facilities
- 14 or acquisition of equipment.
- 15 (a) Madolenihmw . . . . . 25,000
- 16 (b) Kitti . . . . . 25,000
- 17 (3) Airstrip projects, school facility renova-
- 18 tion, dispensary renovation.
- 19 (a) Mokil . . . . . 17,000
- 20 (b) Pingelap . . . . . 17,000
- 21 (4) Roads, water distribution, school
- 22 facility projects.

16 Section 2. Section 2 of Public Law No, 1-146 is hereby amended to  
17 read as follows:

18 "Section 2. All funds appropriated by this act shall be  
19 allotted, managed, administered, and accounted for in accor-  
20 dance with applicable law, including, but not limited to, the  
21 Financial Management Act of 1979. The allottee shall be re-  
22 sponsible for ensuring that these funds, or so much thereof as  
23 may be necessary, are used solely for the purpose specified  
24 in this act, and that no obligations are incurred in excess  
25 of the sum appropriated. The authority of the allottee to

1 obligate funds appropriated by this act shall lapse as of  
2 September 30, 1983."

3 Section 3. This act shall become law upon approval by the Presi-  
4 dent of the Federated States of Micronesia or upon its becoming law  
5 without such approval.
