## AN ACT

To establish an imprest revolving fund for the Guam Liaison Office, for the Honolulu Liaison Office, and for the San Francisco Supply Office of the National Government of the Federated States of Micronesia, to authorize appropriations therefor, to appropriate the sum of \$47,000 therefor, and for other purposes. BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: 1 Section 1. Title. This act shall be known as the "Imprest Revolving Funds Act of 1982." 2 Section 2. Purpose. The purpose of this act is to establish 3 three ongoing imprest revolving funds to provide, subject to the 4 provisions of section 4 of this act, sources of advanced funding for 5 authorized operations expenses of the Guam and Honolulu Liaison 6 Offices; and authorized expenses incurred during official travel by 7 qualified Community College of Micronesia employees and officials, 8 National and State Government employees and officials, and medical 9 10 referral patients and their attendants. Section 3. Establishment. 11 (1) There is hereby established an ongoing imprest 12 revolving fund to be separate from the General Fund or other funds 13 for each of the following offices of the National Government of the 14 Federated States of Micronesia; 15 (a) Guam Liaison Office; 16 (b) Honolulu Liaison Office; and 17 (c) San Francisco Supply Office 18 (2) Any unexpended money in these funds shall not revert 19 to the General Fund nor lapse at the end of the fiscal year. 20 Section 4. Authorized uses of the funds. 21 (1) The fund established pursuant to section 3 of this act 22

1 for the Guam Liaison Office may be utilized as a source of advanced funding for authorized expenses incurred in the operation of that 2 3 office. 4 (2) The fund established pursuant to section 3 of this 5 act for the Honolulu Liaison Office may be utilized as a source of advanced funding for authorized expenses incurred in the operation 6 of that office. 7 8 (3) All of the funds established pursuant to section 3 of 9 this act may be utilized as sources of advanced funding for authorized expenses incurred during travel by: 10 11 (a) Employees and officials of the Community College 12 of Micronesia and employees and officials of any branch, department, 13 office, board, bureau, commission, committee, institution, corporation, or statutory authority of the National or State Governments of the 14 15 Federated States of Micronesia who have been issued valid travel 16 authorizations; and (b) Medical referral patients and their attendants 17 who have been issued valid travel authorizations. 18 (4) The Secretary of Finance of the National Government of 19 the Federated States of Micronesia shall determine "authorized 20 expenses" for the purposes of subsections (1) through (3) of this 21 section through the establishment of policies and procedures. 22 (5) The funds shall not be utilized for any purpose other 23 than as permitted by this section. 24 Section 5.
