#### AN ACT

To appropriate the sum of \$287,800 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1985, for the purpose of funding public projects in the Faichuk area of the State of Truk, and for other purposes.

Section 2. All funds appropriated by this act shall be allotted
managed, administered, and accounted for in accordance with applicabl
law, including, but not limited to, the Financial Management Act of
1979. The allottees shall be the development authorities of the
respective areas of the Faichuk area who shall be responsible for
ensuring that these funds, or so much thereof as may be necessary, ar
used solely for the purpose specified in this act, and that no obliga
tions are incurred in excess of the sum appropriated. The authority
of the allottees to obligate funds appropriated by this act shall
continue until the funds appropriated herein are expended.
Section 3. This act shall become law upon approval by the
