CONGRESSIONAL BILL NO. 3-345, C.D.1,
C.D.2

AN ACT

To amend Public Law No. 3-57 by amending sections 1 and 2 for the purpose of reapportioning funds, providing for specific allottees for certain funds, removing restrictions on the authority of the allottees, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 3-57 is hereby amended
2 to read as follows:

3 "Section 1. Appropriation. The sum of \$720,000, or so much
4 thereof as may be necessary, is hereby appropriated from the
5 General Fund of the Federated States of Micronesia for the
6 fiscal year ending September 30, 1985, for the purpose of
7 funding public projects in the State of Ponape. The sum
8 appropriated herein shall be apportioned as follows:

9 (1) Uh, Nett, Pingelap, and Mokil public projects


2 Section 2. Section 2 of Public Law No. 3-57 is hereby amended
3 to read as follows:

4 "Section 2. Project execution. All funds appropriated by
5 this act shall be allotted, managed, administered, and
6 accounted for in accordance with applicable law, including,
7 but not limited to, the Financial Management Act of 1979,
8 as amended. The allottee for funds appropriated under
9 section 1(1) shall be the Ponape Community Action Agency and
10 the allottee for funds appropriated under section 1(10)(c)
11 shall be the Federated States Development Bank. The
12 allottees shall be responsible for ensuring that these funds,
13 or so much thereof as may be necessary, are used solely for
14 the purposes specified in this act and that no obligations
15 are incurred in excess of the sum appropriated. The authority
16 to obligate funds herein appropriated shall lapse as of
17 September 30, 1985."

18 Section 3. This act shall become law upon approval by the President
19 of the Federated States of Micronesia or upon its becoming law without
20 such approval.
