CONGRESSIONAL BILL NO. 4-126, C.D.1, C.D.2, C.D.3

AN ACT

To appropriate the sum of \$5,158,094 from the General Fund of the Federated States of Micronesia and the sum of \$6,323,142 from the United States Grant Special Fund for the fiscal year ending September 30, 1986, for the operations of the executive branch, legislative branch, National judiciary, Public Auditor, agencies of the National Government, and for special programs, contributions, grants, subsidies, and refunds of the National Government during fiscal year 1986; to establish employment ceilings; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	(2) The number of positions authorized applies individually
2	to each of the departments and offices of the executive and legislative
3	branches, the National judiciary, the Public Auditor, and to the agencies
4	as provided in subsection (1) of this section, except that the President
5	may transfer up to 12 positions between the departments and offices of
6	the executive branch. This authorization of positions covers all permanen
7	employees, all contract personnel whose employment extends for 1 year
8	or more, and all positions funded from United States federal programs.
9	No funds may be expended for unbudgeted positions.
.0	Section 8. Reprogramming.
.1	(1) The President or his designee may reprogram up to 10
.2	percent to and from the funds appropriated to each of the subsections
3	in section 1, and may reprogram up to 15 percent to and from the funds
4	appropriated in each of the paragraphs within the subsections of
.5	section 1.
.6	(2) The Speaker or his designee may reprogram up to 10
.7	percent to and from the funds appropriated to each of the subsections
.8	in section 2, and may reprogram up to 15 percent to and from the funds
9	appropriated in each of the paragraphs within the subsections of
20	section 2.
21	(3) The Chief Justice or his designee may reprogram up
22	to 15 percent to and from the funds appropriated in each of the sub-
23	sections in section 3.
24	(4) The Public Auditor may reprogram up to 15 percent to
25	and from the funds appropriated in each of the subsections in section 4.

1	(5) Allottees of funds may reprogram up to 15 percent to
2	and from the funds appropriated in each of the paragraphs within the
3	subsections of section 5.
4	Section 9. Allotment and management of funds and lapse date.
5	All funds appropriated by this act shall be allotted, managed, adminis-
6	tered, and accounted for in accordance with applicable law, including, but
7	not limited to, the Financial Management Act of 1979, as amended. Each
8	allottee shall be responsible for ensuring that these funds, or so much
9	thereof as may be necessary, are used solely for the purposes specified in
0	this act, and that no obligations are incurred in excess of 25 percent of
1	the sums appropriated for each object class; PROVIDED that no equipment
2	over \$50 may be purchased and no new positions may be created. The authori
3	of the allottees to obligate funds appropriated by this act, except those
4	appropriated by section 5(5) shall lapse as of September 30, 1986. The
5	25 percent restriction on obligations shall not be applicable to the sums
6	appropriated under section 6 of this act.
7	Section 10. Effective date. This act shall become law upon
8	approval by the President of the Federated States of Micronesia or upon
9	its becoming law without such approval.
