## AN ACT

To appropriate the sum of \$350,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1986, for the purpose of funding public projects in the State of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$350,000, or so much thereof as may be

1	Section 3. All funds appropriated by this act shall be allotted,
2	managed, administered, and accounted for in accordance with applicable
3	law, including, but not limited to, the Financial Management Act of
4	1979. The allottee shall be the chairman of the Kosrae State
5	Improvement Commission for all the appropriations herein, except for
6	appropriations under subsections (5)(a), (c), (d), (e), (f), (g), (h),
7	and (j) of section 2, the allottee for which shall be the Governor of
8	Kosrae State, and subsection (5)(b) of section 2, the allottee for which
9	shall be the chairman of the Kosrae congressional delegation. The
10	allottees shall be responsible for ensuring that these funds, or so
11	much thereof as may be necessary, are used solely for the purposes

specified in this act, and that no obligations are incurred in excess

of the sum appropriated. The authority of the allottees to obligate
