CONGRESSIONAL BILL NO. 4-175, C.D.1,
C.D.2

AN ACT

To appropriate the sum of \$1,170,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1986, for the purpose of funding public projects in the State of Truk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$1,170,000, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending September
4 30, 1986, for the purpose of funding public projects in the State of
5 Truk.

6 Section 2. The sum appropriated under section 1 of this act
7 shall be apportioned as follows:

3 Section 3. All funds appropriated by this act shall be allotted,
4 managed, administered, and accounted for in accordance with applicable
5 law, including, but not limited to, the Financial Management Act of
6 1979. The allottee of funds appropriated under subsection (1)(i) of
7 section 2 shall be the Truk Lagoon radio association. The allottee
8 of funds appropriated under subsection (1)(j) and subsection (9)(d)
9 of section 2 shall be the chairman of the Truk congressional dele-
10 gation. The other allottees shall be the development authorities
11 for the respective areas of Truk State. The allottees shall be
12 responsible for ensuring that these funds, or so much thereof as may
13 be necessary, are used solely for the purposes specified in this act,
14 and that no obligations are incurred in excess of the sum appro-
15 priated. The authority of the allottees to obligate funds appro-
16 priated by this act shall remain effective until funds are fully
17 expended. The allottees shall make a written report of the status
18 of the funds appropriated hereunder to the Congress of the Federated
19 States of Micronesia during its October regular session each year
20 until such time as all funds are fully expended.
