CONGRESSIONAL BILL No. 4-292, C.D.1

AN ACT

To further amend section 207 of title 2 of the Code of the Federated States of Micronesia, as amended by Public Law No. 3-24, to require the advice and consent of the Congress for appointments to the Board of Advisors for the Investment Development Fund, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 207 of title 2 of the Code of the Federated
2 States of Micronesia, as amended by Public Law No. 3-24, is hereby
3 further amended to read as follows:

4 "Section 207. Appointment authority.

5 (1) The President shall nominate and, with the
6 advice and consent of the Congress, as provided in article
7 X, section 2(d), of the Constitution, shall appoint the
8 secretaries of departments and their deputies, if any,
9 and the heads of the offices of the Attorney General,
10 Budget, Planning and Statistics, and the Public Defender,
11 and their deputies, if any, including the secretaries,
12 deputies, and heads of departments and offices established
13 by subsequent law; and including the chairman and the
14 members of the Board of Advisors for the Investment
15 Development Fund to be appointed by the President;
16 provided that nothing herein shall be construed to
17 require the appointment of the deputies named above.

18 (2) The President or his designee may appoint
19 officers and employees not included in subsection (1)
20 of this section, without advice and consent of the
21 Congress; provided that such appointments are not
22 inconsistent with the provisions of this chapter or

1 other laws of the Federated States.


2 (3) The President shall not resubmit the nomination
3 of any person to the Congress for its action if the same
4 Congress shall have previously rejected such nomination,
5 unless the Congress shall by resolution authorize such
6 resubmission.

7 (4) With the exception of the Chief Justice and
8 Associate Justices of the Supreme Court, the Public
9 Auditor, and members of boards, commissions, and other
10 entities with fixed terms, a public official whose
11 appointment is subject to the advice and consent of the
12 Congress shall submit his resignation no later than 30
13 days after the inauguration of the President of the
14 Federated States of Micronesia, or at the time a new
15 nominee for such position is confirmed by the Congress,
16 whichever is earlier. The President may renominate the
17 same public official for the same position subject to the
18 advice and consent of the Congress.

19 (5) The provisions of this section shall become
20 effective retroactive to May 1, 1983."

1 Section 2. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its becoming
3 law without such approval.
