To further amend title 2 of the Code of the Federated States of Micronesia, as amended by Public Law No. 3-24, by amending sections 203 and 204 for the purposes of establishing a Department of Transportation; eliminating the Department of Social Services; establishing the Office of Education and the Office of Health Services; and for other purposes.
