AN ACT

To appropriate the sum of \$180,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1987, for the purpose of funding the operations of the Micronesian Legal Services Corporation in the Federated States of Micronesia, including the construction and furnishing of a new office building for use by the Micronesian Legal Services Corporation in Pohnpei, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. The sum of \$180,000, or so much thereof as may be
2	necessary, is hereby appropriated from the General Fund of the Federated
3	States of Micronesia for the fiscal year ending September 30, 1987,
4	for the purpose of funding the operations of the Micronesian Legal
5	Services Corporation in the Federated States of Micronesia, including
6	the construction and furnishing of a new office building for use
7	by the Micronesian Legal Services Corporation in Pohnpei. The
8	funds appropriated by this act for the construction of the office
9	building shall be deemed to have come from the Compact capital
10	account.
11	Section 2. The sum appropriated under section 1 of this act shall
12	be apportioned as follows:
13	(1) Operations of the Micronesian Legal Services Corporation
14	in the Federated States of Micronesia \$100,000
15	(2) Construction of the new office building in
16	Pohnpei
17	(3) Furnishings for the new office building in
18	Pohnpei

Section 3. The office building constructed with the funds

20 appropriated by this act shall be the property of the Government of the

21 Federated States of Micronesia. No funds appropriated for the

22 construction of the office building shall be allotted until:

1	(1) An agreement recognizing that the office building is the
2	property of the Government of the Federated States of Micronesia and
3	constitutes a valuable improvement is entered into between the
4	Government and the owner of the land upon which the office building is
5	to be constructed; and
6	(2) An agreement setting forth the terms and conditions
7	upon which the office building may be used by the Micronesian Legal
8	Services Corporation is entered into by the Government of the Federated
9	States of Micronesia and the Micronesian Legal Services Corporation.
10	Section 4. All funds appropriated by this act shall be allotted,
11	managed, administered, and accounted for in accordance with applicable
1.2	law, including, but not limited to, the Financial Management Act of
13	1979. The allottee shall be responsible for ensuring that these funds,
14	or so much thereof as may be necessary, are used solely for the purposes
15	specified in this act, and that no obligations are incurred in excess of
L6	the sum appropriated. The authority of the allottee to obligate funds
L7	appropriated by this act shall lapse as of September 30, 1987.
L8	Section 5. This act shall become law upon approval by the
19	President of the Federated States of Micronesia or upon its becoming law
20	without such approval.
