FIFTH CONGRESS OF THE FEDERATED STATES OF MICRONESIA

FIRST SPECIAL SESSION, 1987 CONGRESSIONAL BILL No. 5-94, C.D.1, C.D.2, C.D.3, C.D.4, C.D.5

AN ACT

To appropriate the sum of \$8,122,475 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1988, for the operations of the executive branch, legislative branch, National judiciary, Public Auditor, agencies of the National Government, and for special programs, grants, subsidies, contributions, and refunds of the National Government during fiscal year 1988; to provide funding for the College of Micronesia from funds available under Compact section 216(a)(3); to establish a budget for Compact section 216(a)(1) and to appropriate special funds available therefor under the Compact; to establish employment ceilings; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 12 in section 2, and may reprogram up to 15 percent to and from the funds
- 13 appropriated in each of the paragraphs within the subsections of
- 14 section 2.
- 15 (3) The Chief Justice or his designee may reprogram up
- 16 to 15 percent to and from the funds appropriated in each of the
- 17 subsections in section 3.
- 18 (4) The Public Auditor may reprogram up to 15 percent to
- 19 and from the funds appropriated in each of the subsections in section 4.
- 20 (5) Allottees of funds may reprogram up to 15 percent to
- 21 and from the funds appropriated in each of the paragraphs within the
- 22 subsections of section 5.
- 23 (6) Notwithstanding the provisions of subsections (1) through
- 24 (5) of this section, no funds may be reprogrammed from any personnel
- 25 account.

1	Section 14. Allotment and management of funds and lapse date.
2	All funds appropriated by this act shall be allotted, managed,
3	administered, and accounted for in accordance with applicable law,
4	including, but not limited to, the Financial Management Act of 1979,
5	as amended. Each allottee shall be responsible for ensuring that
6	these funds, or so much thereof as may be necessary, are used solely
7	for the purposes specified in this act, and that no obligations are
8	incurred in excess of the sum appropriated. The authority of the
9	allottees to obligate funds appropriated by this act shall lapse as
10	of September 30, 1988.
11	Section 15. Effective date. This act shall become law upon
12	approval by the President of the Federated States of Micronesia or
13	upon its becoming law without such approval.
