AN ACT

To further amend Public Law No. 5-15, as amended by Public Laws Nos. 5-28, 5-45, and 5-48, by further amending section 5, as amended by Public Laws Nos. 5-28 and 5-48, for the purpose of appropriating the sum of \$7,300 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1988, as supplemental funding for the Postal Services, and for other purposes.
