

AN ACT

To further amend Public Law No. 5-15, as amended by Public Laws Nos. 5-28, 5-45 and 5-48, by further amending section 11, as amended by Public Laws Nos. 5-28 and 5-48, for the purpose of reallocating funds for the purpose of funding Yap youth activities and programs, Truk sports activities and programs, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 11 of Public Law No. 5-15, as amended by
2 Public Laws Nos. 5-28 and 5-48, is hereby further amended to read as
3 follows:

4 "Section 11. Other National Government programs, grants,
5 subsidies, contributions, and refunds. The sum of
6 \$1,643,259, or so much thereof as may be necessary, is
7 hereby appropriated from the General Fund of the Federated
8 States of Micronesia for the fiscal year ending September 30,
9 1988, for special programs, grants, subsidies, contributions,
10 and refunds of the National Government of the Federated States
11 of Micronesia during fiscal year 1988. The sum appropriated
12 by this section shall be apportioned as follows:

- 15 (b) Trade Training and Testing
- 16 Program..... 191,000
- 17 (c) South Pacific Festival of Arts..... 56,400
