FIFTH CONGRESS OF THE FEDERATED STATES OF MICRONESIA

SECOND REGULAR SESSION, 1987 CONGRESSIONAL BILL No. 5-200, C.D.1, C.D.2

AN ACT

To appropriate the sum of \$35,984 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1988, for the purpose of reimbursing the State of Truk and the State of Yap for their respective expenses incurred in connection with the FSM Congressional elections held in those States in 1985 and 1987, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$35,984, or so much thereof as may be
- 2 necessary, is hereby appropriated from the General Fund of the
- 3 Federated States of Micronesia for the fiscal year ending September 30,
- 4 1988, for the purpose of reimbursing the State of Truk and the State
- 5 of Yap for their respective expenses incurred in connection with the
- 6 FSM Congressional elections held in those States in 1985 and 1987.
- 7 Section 2. The funds appropriated under section 1 of this act
- 8 shall be apportioned as follows:
- 9 (1) Reimbursement of election expenses of
- 10 Truk State...... \$20,657
- 11 (2) Reimbursement of election expenses of
- 12 Yap State..... 15,327
- 13 Section 3. All funds appropriated by this act shall be allotted,
- 14 managed, administered, and accounted for in accordance with applicable
- 15 law, including, but not limited to, the Financial Management Act of
- 16 1979, as amended; PROVIDED, however, that no funds shall be transferred
- 17 or disbursed from the General Fund of the Federated States of Micro-
- 18 nesia pursuant to this act except upon the submission to the allottee
- 19 of a receipt or other documentary evidence which substantiates an
- 20 expense incurred in connection with the FSM Congressional elections
- 21 held in 1985 or in 1987, and then, only to the extent that such amount
- 22 is available and unobligated pursuant to the terms of this act. The

1	allottee for the funds appropriated under subsection (1) of section 2
2	of this act shall be the National Election Commissioner of the State
3	of Truk. The allottee of the funds appropriated under subsection (2)
4	of section 2 of this act shall be the National Election Commissioner
5	of the State of Yap. Each allottee shall be responsible for ensuring
6	that these funds, or so much thereof as may be necessary, are used
7	solely for the purpose specified in this act, and that no obligations
8	are incurred in excess of the sum appropriated. The authority of the
9	allottees to obligate funds appropriated by this act shall lapse as of
10	September 30, 1988.
11	Section 4. This act shall become law upon approval by the
12	President of the Federated States of Micronesia or upon its becoming
13	law without such approval.
