THIRD SPECIAL SESSION, 1988

CONGRESSIONAL BILL NO. 5-312, C.D.1

AN ACT

To amend Public Law No. 3-38, the Postal Crimes Act, codified as sections 201 through 204 and 207 through 234 of title 39 of the Code of the Federated States of Micronesia, by amending sections 206 and 222, codified as sections 212 and 228 of title 39 of the Code of the Federated States of Micronesia; by adding new sections 235 through 245 of title 39 of the Code of the Federated States of Micronesia; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: 1 Section 1. Section 212 of title 39 of the Code of the Federated 2 States of Micronesia is hereby amended to read as follows: 3 "Section 212. Prompt delivery of mail. 4 (1) Whoever, having charge or control of delivering mail from an arriving vessel to the Postmaster or Post 5 6 Office, fails to so deliver that mail, including all 7 letters and packages within his power or control addressed 8 to or destined for the Postmaster or Post Office, within 9 three hours after it is available for such delivery, shall 10 be fined not more than \$200. 11 (2) Whoever, having charge or control of delivering 12 mail from an arriving aircraft to the Postmaster or Post Office, fails to so deliver that mail, including all 13 14 letters and packages within his power or control addressed

to or destined for the Postmaster or Post Office, within
one hour after it is available for such delivery, shall
be fined not more than \$200.

(3) Whoever, having charge or control of delivering
mail from an arriving vessel or aircraft to the Postmaster or Post Office, or from the Postmaster or Post
Office to a vessel or aircraft, engages in an
unnecessary detour from the delivery route, shall be

2	Section 2. Section 228 of title 39 of the Code of the Federated
3	States of Micronesia is hereby amended to read as follows:
4	"Section 228. Injurious articles as nonmailable.
5	(1) All kinds of poison, and all articles and
б	compositions containing poison, and controlled substances
7	as defined in subsection (3) of section 1112 of title 11
8	of this Code, and all poisonous animals, insects, reptiles,
9	and all explosives, inflammable materials, and mechanical,
10	chemical, or other devices or compositions which may
11	ignite or explode, and all disease germs or scabs, and all
12	other natural or artificial articles, compositions, or
13	material which may kill or injure another, or injure the
14	mails or other property, are nonmailable matter and shall
15	not be conveyed in the mails or delivered from any post
16	office or station thereof, nor by any officer or employee
17	of the Postal Service.
18	(2) The Postal Service may permit the transmission
19	in the mails, under such rules and regulations as it shall
20	prescribe as to preparation and packing, of any such
21	articles which are not outwardly or of their own force
22	dangerous or injurious to life, health, or property.
23	(3) The transmission in the mails of poisonous
24	drugs and medicines and controlled substances may be
25	limited by the Postal Service to shipments of such

1	articles from the manufacturer thereof or dealer therein
2	to licensed physicians, surgeons, dentists, pharmacists,
3	and veterinarians under such rules and regulations as it
4	shall prescribe.
5	(4) All spirituous, vinous, malted, fermented, or
6	other intoxicating liquors of any kind are nonmailable and
7	shall not be deposited in or carried through the mails.
8	(5) All knives having a blade which opens auto-
9	matically (a) by hand pressure applied to a button or
10	other device in the handle of the knife, or (b) by
11	operation of inertia, gravity, or both, are nonmailable
12	and shall not be deposited in or carried by the mails or
13	delivered by any officer or employee of the Postal Service.
14	(6) Whoever knowingly deposits for mailing or
1.5	delivery, or knowingly causes to be delivered by mail,
16	according to the direction thereon, or at any place at
17	which it is directed to be delivered by the person to
18	whom it is addressed, anything declared nonmailable by
19	this section, unless in accordance with the rules
20	and regulations authorized to be prescribed by the
21	Postmaster General, shall be fined not more than \$1,000, or
22	imprisoned not more than one year, or both.
23	(7) Whoever knowingly deposits for mailing or
24	delivery, or knowingly causes to be delivered by mail,
25	according to the direction thereon, or at any place to

1	which it is directed to be delivered by the person to
2	whom it is addressed, anything declared nonmailable by
3	this section, whether or not transmitted in accordance
4	with the rules and regulations authorized to be
5	prescribed by the Postmaster General, with intent to kill
б	or injure another, or injure the mails or other property,
7	shall be fined not more than \$10,000, or imprisoned not
8	more than twenty years, or both.
9	(8) Whoever is convicted of any crime prohibited by
10	this section, which has resulted in the death of any
11	person, shall be subject also to imprisonment for life,
12	if the Court in its discretion so directs."
13	Section 3. Title 39 of the Code of the Federated States of
14	Micronesia is hereby amended by adding a new section 235 to read as
15	follows:
16	"Section 235. Mailing threatening communications.
17	(1) Whoever knowingly deposits in any post office
18	or authorized depository for mail matter, to be sent or
19	delivered by the Postal Service or knowingly causes to be
20	delivered by the Postal Service according to the
21	direction thereon, any communication, with or without a
22	name or designating mark subscribed thereto, addressed to
23	any other person, and containing any demand or request
24	for ransom or reward for the release of any kidnapped
25	person, shall be fined not more than \$5,000 or

1	imprisoned not more than 10 years, or both.
2	(2) Whoever, with intent to extort from any
3	person any money or other thing of value, so deposits,
4	or causes to be delivered, as aforesaid, any communi-
5	cation containing any threat to kidnap any person or any
6	threat to injure the person of the addressee or of another,
7	shall be fined not more than \$5,000 or imprisoned not more
8	than 10 years, or both.
9	(3) Whoever knowingly so deposits or causes to be
10	delivered as aforesaid, any communication with or without
11	a name or designating mark subscribed thereto, addressed
12	to any other person and containing any threat to kidnap
13	any person or any threat to injure the person of the
14	addressee or of another, shall be fined not more than
15	\$1,000 or imprisoned not more than 3 years, or both.
16	(4) Whoever, with intent to extort from any person
17	any money or other thing of value, knowingly so deposits
18	or causes to be delivered, as aforesaid, any communication,
19	with or without a name or designating mark subscribed
20	thereto, addressed to any other person and containing any
21	threat to injure the property or reputation of the
22	addressee or of another, or the reputation of a deceased
23	person, or any threat to accuse the addressee or any other
24	person of a crime, shall be fined not more than \$500 or
25	imprisoned not more than 2 years, or both."

1	Section 4. Title 39 of the Code of the Federated States of
2	Micronesia is hereby amended by adding a new section 236 to read
3	as follows:
4	"Section 236. Libelous matter on wrappers or envelopes.
5	(1) All matter otherwise mailable by law, upon the
6	envelope or outside cover or wrapper of which, or any
7	postal card upon which is written or printed or otherwise
8	impressed or apparent any delineation, epithet, term, or
9	language of libelous, scurrilous, defamatory, or threat-
10	ening character, or calculated by the terms or manner or
11	style of display and obviously intended to reflect
12	injuriously upon the character or conduct of another,
13	is nonmailable matter, and shall not be conveyed in
14	the mails nor delivered from any post office nor by
15	any letter carrier, and shall be withdrawn from the mails
16	under such regulations as the Postal Service shall
17	prescribe.
18	(2) Whoever knowingly deposits for mailing or
19	delivery, anything declared by this section to be
20	nonmailable matter, or knowingly takes the same from
21	the mails for the purpose of circulating or disposing of
22	or aiding in the circulation or disposition of the same,
23	shall be fined not more than \$1,000 or imprisoned not more
24	than 1 year, or both."
25	Section 5. Title 39 of the Code of the Federated States of

1	Micronesia is hereby amended by adding a new section 237 to read as
2	follows:
3	"Section 237. Mailing indecent matter on wrappers or
4	envelopes.
5	(1) All matter otherwise mailable by law, upon the
б	envelope or outside cover or wrapper of which, and all
7	postal cards upon which, any delineations, epithets,
8	terms, or language of an indecent, lewd, lascivious, or
9	obscene character are written or printed or otherwise
10	impressed or apparent, are nonmailable matter, and shall
11	not be conveyed in the mails nor delivered from any post
12	office nor by any letter carrier, and shall be withdrawn
13	from the mails under such regulations as the Postal
14	Service shall prescribe.
15	(2) Whoever knowingly deposits for mailing or
16	delivery, anything declared by this section to be non-
17	mailable matter, or knowingly takes the same from the
18	mails for the purpose of circulating or disposing of or
19	aiding in the circulating or disposition of the same, shall
20	be fined not more than \$5,000 or imprisoned not more than
21	3 years, or both."
22	Section 6. Title 39 of the Code of the Federated States of
23	Micronesia is hereby amended by adding a new section 238 to read as
24	follows:
25	"Section 238. Frauds and swindles. Whoever, having

2	defraud, or for obtaining money or property by means of
3	false or fraudulent pretenses, representations, or
4	promises, or to sell, dispose of, loan, exchange, alter,
5	give away, distribute, supply, or furnish or procure for
6	unlawful use any counterfeit or spurious coin, obligation,
7	security, or other article, or anything represented to be
8	or intimated or held out to be such counterfeit or
9	spurious article, for the purpose of executing such scheme
10	or artifice or attempting so to do, places in any post
11	office or authorized depository for mail matter, any matter
12	or thing whatever to be sent or delivered by the Postal
13	Service, or takes or receives therefrom, any such matter
14	or thing, or knowingly causes to be delivered by mail
15	according to the direction thereon, or at the place at
16	which it is directed to be delivered by the person to
17	whom it is addressed, any such matter or thing, shall be
18	fined not more than \$1,000 or imprisoned not more than
19	5 years, or both."
20	Section 7. Title 39 of the Code of the Federated States of
21	Micronesia is hereby amended by adding a new section 239 to read as
22	follows:
23	"Section 239. Fictitious name or address. Whoever, for
24	the purpose of conducting, promoting, or carrying on by
25	means of the Postal Service, any scheme or device

1	mentioned in section 238 of this title or any other
2	unlawful business, uses or assumes, or requests to be
3	addressed by, any fictitious, false, or assumed title, name,
4	or address or name other than his own proper name, or takes
5	or receives from any post office or authorized depository
6	of mail matter, any letter, postal card, package, or other
7	mail matter addressed to any such fictitious, false, or
8	assumed title, name, or address, or name other than his own
9	proper name, shall be fined not more than \$1,000 or
10	imprisoned not more than 5 years, or both."
11	Section 8. Title 39 of the Code of the Federated States of
12	Micronesia is hereby amended by adding a new section 240 to read as
13	follows:
14	"Section 240. False claims for postal losses.
15	(1) Whoever makes, alleges, or presents any claim or
16	application for indemnity for the loss of any registered
17	or insured letter, parcel, package, or other article or
18	matter, or the contents thereof, knowing such claim or
19	application to be false, fictitious, or fraudulent; or
20	(2) Whoever for the purpose of obtaining or aiding
21	to obtain the payment or approval of any such claim or
22	application, makes or uses any false statement, certifi-
23	cate, affidavit, or deposition; or
24	(3) Whoever knowingly and willfully misrepresents, or
25	misstates, or, for the purpose aforesaid, knowingly and

1	willfully conceals any material fact or circumstance in
2	respect of any such claim or application for idemnity
3	shall be fined not more than \$500 or imprisoned not more
4	than 1 year, or both; PROVIDED, however, that if the amount
5	of such claim or application for indemnity is less
б	than \$100 only a fine shall be imposed."
7	Section 9. Title 39 of the Code of the Federated States of
8	Micronesia is hereby amended by adding a new section 241 to read as
9	follows:
10	"Section 241. Money orders.
11	(1) Whoever, with intent to defraud, falsely makes,
12	forges, counterfeits, engraves, or prints any order in
13	imitation of or purporting to be a blank money order or
14	a money order issued by or under the direction of the
15	Postal Service; or
16	(2) Whoever forges or counterfeits the signature or
17	initials of any person authorized to issue money orders
18	upon or to any money order, postal note, or blank therefor
19	provided or issued by or under the direction of the Postal
20	Service, or post office department or corporation of any
21	foreign country, and payable in the Federated States of
22	Micronesia, or any material signature or indorsement
23	thereon, or any material signature to any receipt or
24	certificate of identification thereof; or
25	(3) Whoever falsely alters, in any material respect,

1	any such money order or postal note; or
2	(4) Whoever, with intent to defraud, passes, utters or
3	publishes or attempts to pass, utter or publish any such
4	forged or altered money order or postal note, knowing
5	any material initials, signature, stamp impression or
6	indorsement thereon to be false, forged, or counterfeited,
7	or any material alteration therein to have been falsely
8	made; or
9	(5) Whoever issues any money order or postal note
10	without having previously received or paid the full amount
11	of money payable therefor, with the purpose of fraudulently
12	obtaining or receiving, or fraudulently enabling any
13	other person, either directly or indirectly, to obtain or
14	receive from the Federated States of Micronesia or Postal
15	Service, or any officer, employee, or agent thereof, any
16	sum of money whatever; or
17	(6) Whoever embezzles, steals, or knowingly converts
18	to his own use or to the use of another, or without
19	authority converts or disposes of any blank money order
20	form provided by or under the authority of the Postal
21	Service; or
22	(7) Whoever receives or possesses any such money order
23	form with the intent to convert it to his own use or gain or
24	use or gain of another knowing it to have been embezzled,
25	stolen or converted; or

1	(8) Whoever, with intent to defraud the Federated
2	States of Micronesia, the Postal Service, or any person,
3	transmits, presents, or causes to be transmitted or
4	presented, any money order or postal note knowing the
5	same:
6	(a) To contain any forged or counterfeited
7	signature, initials, or any stamped impression, or
8	(b) To contain any material alteration
9	therein unlawfully made, or
10	(c) To have been unlawfully issued without
11	previous payment of the amount required to be paid
12	upon such issue, or
13	(d) To have been stamped without lawful
14	authority; or
15	(9) Whoever steals, or with intent to defraud or
16	without being lawfully authorized by the Postal Service,
17	receives, possesses, disposes of or attempts to dispose
18	of any postal money order machine or any stamp, tool,
19	or instrument specifically designed to be used in preparing
20	or filling out the blanks on postal money order forms
21	shall be fined not more than \$5,000 or imprisoned not more
22	than 5 years, or both."
23	Section 10. Title 39 of the Code of the Federated States of
24	Micronesia is hereby amended by adding a new section 242 to read as
25	follows:

1	"Section 242. Robbery of mail, money or other property of
2	the Postal Service. Whoever assaults any person having
3	lawful charge, control, or custody of any mail matter
4	or of any money or other property of the Postal Service,
5	with intent to rob, steal, or purloin such mail matter,
б	money, or other property of the Postal Service, or robs
7	any such person of mail matter, or of any money, or other
8	property of the Postal Service, shall, for the first
9	offense, be imprisoned not more than 10 years; and if
10	in effecting or attempting to effect such robbery
11	he wounds the person having custody of such mail, money,
12	or other property of the Postal Service, or puts his life
13	in jeopardy by the use of a dangerous weapon, or for a
14	subsequent offense, shall be imprisoned not more than 20
15	years."
16	Section 11. Title 39 of the Code of the Federated States of
17	Micronesia is hereby amended by adding a new section 243 to read as
18	follows:
19	"Section 243. Burglary of post office. Whoever forcibly
20	breaks into or attempts to break into any post office, or
21	any building used in whole or in part as a post office, with
22	intent to commit in such post office, or building or part
23	thereof, so used, any larceny or other depredation, shall
24	be fined not more than \$1,000 or imprisoned not more than
25	5 years, or both."

1	Section 12. Title 39 of the Code of the Federated States of
2	Micronesia is hereby amended by adding a new section 244 to read
3	as follows:
4	"Section 244. Confiscation of nonmailable items. The
5	Postmaster General or his designee may confiscate any
6	item declared nonmailable by this act which is placed in
7	the mail. Items so confiscated shall be turned over to
8	the Attorney General of the Federated States of Micronesia
9	for proper disposition. Nonmailable items may be
10	confiscated regardless of whether or not the person
11	sending or receiving such items is prosecuted for a
12	violation of this act."
13	Section 13. This act shall become law upon approval by the
14	President of the Federated States of Micronesia or upon its becoming
15	law without such approval.
