CONGRESSIONAL BILL No. 5-329, C.D.1, C.D.2, C.D.3

AN ACT

To appropriate the sum of \$1,501,098 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1989, for the purpose of funding public projects in Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

17	managed, administered, and accounted for in accordance with applicable
18	law, including, but not limited to, the Financial Management Act of
19	1979. The allottee of the funds appropriated under sub-paragraphs
20	(a), (b), (c), (d), (e), (f), and (g) of subsection (1) of section 2
21	of this act shall be the Governor of the State of Pohnpei. The
22	allottee of the funds appropriated under sub-paragraph (h) of
23	subsection (1) of section 2 of this act, and under sub-paragraphs
24	(d)(ii), (e), (f), (g), (h) and (k)(ii) of subsection (2) of section
25	2 of this act shall be the Pohnpei Community Action Agency. The

- 1 allottee of the funds appropriated under sub-paragraph (a) of sub-
- 2 section (2) of section 2 of this act shall be the Menin Keder Lapalap
- 3 of the Madolenihmw Municipal Government. The allottee of the funds
- 4 appropriated under sub-paragraph (b) of subsection (2) of section 2
- 5 of this act shall be the Luhken Menlap of the Kitti Municipal
- 6 Government. The allottee of the funds appropriated under sub-
- 7 paragraph (c) of subsection (2) of section 2 of this act shall be the
- 8 Kolonia Town Mayor. The allottee of the funds appropriated under sub-
- 9 paragraph (d)(i) of subsection (2) of section 2 of this act shall be
- 10 the Chief Magistrate of the Sokehs Municipal Government. The allottee
- 11 of the funds appropriated under sub-paragraph (i) of subsection (2)
- 12 of section 2 of this act shall be the Luhkenkolwof of Sapwuahfik.
- 13 The allottee of the funds appropriated under sub-paragraph (j) of
- 14 subsection (2) of section 2 of this act shall be the Chief Magistrate
- 15 of the Nukuoro Municipal Government. The allottee of the funds
- 16 appropriated under sub-paragraph (k)(i) of subsection (2) of section
- 17 2 of this act shall be the Chief Magistrate of the Kapingamarangi
- 18 Municipal Government. The allottee of the funds appropriated under
- 19 subsection (3) of section 2 of this act shall be the Chairman of the
- 20 Pohnpei Congressional Delegation. Each allottee shall be responsible
- 21 for ensuring that these funds, or so much thereof as may be necessary,
- 22 are used solely for the purposes specified in this act, and that no
- 23 obligations are incurred in excess of the sum appropriated. The
- 24 authority of the allottees to obligate funds appropriated by this act
- 25 shall lapse as of September 30, 1989.
