CONGRESSIONAL BILL No. 5-185, C.D.1

## AN ACT

To amend title 54 of the Code of the Federated States of Micronesia by amending section 201 for the purpose of levying an ad valorem import tax on the importation of laundry bar soap for resale, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- Section 1. Section 201 of title 54 of the Code of the Federated
- 2 States of Micronesia is hereby amended to read as follows:
- "Section 201. Import taxes Levy and rates. The following 3 4 import taxes are hereby levied on all products specified herein which are imported into the Federated States of 5 Micronesia for resale except that the taxes levied under 6 subsections (1), (2), (5), (6), and (7) of this section shall 7 8 apply to products which are imported into the Federated 9 States of Micronesia for personal use and consumption as 10 well as for resale:
  - (1) cigarettes, at the rate of seven cents per every twenty cigarettes, except that any person may bring into any State of the Federated States of Micronesia up to one carton or two hundred cigarettes per trip tax-free, if such cigarettes are for that person's use and consumption and not for resale;
  - (2) tobacco, other than cigarettes, at the rate of fifty percent ad valorem, except that any person may bring into any State of the Federated States of Micronesia up to one pound of tobacco or twenty cigars per trip tax-free, if such tobacco products are for that person's use and consumption and not for resale;
