

AN ACT

To amend sections 1, 5 and 14 of Public Law No. 5-52 for the purpose of appropriating the sum of \$116,882 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1989, as supplemental funding for the executive branch and agencies of the National Government; adjusting employment ceilings; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 1 of Public Law No. 5-52 is hereby amended to read as follows:

"Section 1. Operating expenses of the executive branch. The sum of \$8,129,469, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1989, for the operations of the executive branch of the National Government of the Federated States of Micronesia during fiscal year 1989. The sum appropriated by this section shall be apportioned as follows:

(c) Contractual services, grants, subsidies, and contributions..... 54,200
(d) Others..... 128,300
(2) Department of External Affairs

9 Government. The sum of \$1,426,045, or so much thereof  
10 as may be necessary, is hereby appropriated from the General  
11 Fund of the Federated States of Micronesia for the fiscal  
12 year ending September 30, 1989, for the operations of  
13 independent agencies, commissions, authorities, boards,  
14 bureaus, and other organizations of the National Government  
15 of the Federated States of Micronesia during fiscal year  
16 1989. The sum appropriated by this section shall be  
17 apportioned as follows:



16 (2) The number of positions authorized applies  
17 individually to each of the departments and offices of the  
18 executive and legislative branches, the National judiciary,  
19 the Public Auditor, and to the agencies as provided in  
20 subsection (1) of this section, except that the President  
21 may transfer up to 12 positions between the departments  
22 and offices of the executive branch. This authorization  
23 of positions covers all permanent employees and all contract  
24 personnel whose employment extends for 1 year or more. No  
25 funds may be expended for unbudgeted positions."

1 Section 4. This act shall become law upon approval by the  
2 President of the Federated States of Micronesia or upon its becoming  
3 law without such approval.
