FIFTH CONGRESS OF THE FEDERATED STATES OF MICRONESIA

THIRD SPECIAL SESSION, 1988

CONGRESSIONAL BILL No. 5-333, C.D.1,
C.D.2, C.D.3

AN ACT

To appropriate the sum of \$2,048,216 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1989, for the purpose of funding statewide and other public projects in Truk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Statewide public projects. The sum of \$110,216, or
2 so much thereof as may be necessary, is hereby appropriated from the
3 General Fund of the Federated States of Micronesia for the fiscal
4 year ending September 30, 1989, for the purpose of funding certain
5 statewide public projects in Truk State. The sum appropriated by
6 this section shall be apportioned as follows:

23 Section 8. Allotment and management of funds and lapse date.
24 All funds appropriated by this act shall be allotted, managed,
25 administered, and accounted for in accordance with applicable

1 law, including, but not limited to, the Financial Management Act of
2 1979. The allottee of the funds appropriated under sections 1 and 3
3 of this act shall be the Governor of Truk State, except for the funds
4 appropriated by sub-paragraph (3) of section 1 for which the allottee
5 shall be the Executive Director of the Truk Organization of Community
6 Action. The allottee of the funds appropriated under section 2 of
7 this act shall be the Northern Namoneas Development Authority. The
8 allottee of the funds appropriated under sections 4 and 7 of this act,
9 under subsections (5) and (6) of section 5 of this act, and under
10 subsections (4)(a)(i), (4)(b)(i), (4)(c)(i), (4)(d)(i), and
11 sub-paragraph (7) of section 6 of this act shall be the Chairman of
12 the Truk State Congressional Delegation. The allottee of the funds
13 appropriated under sub-paragraphs (1) and (4) of section 5 of this act
14 shall be the Lower Mortlocks Development Authority. The allottee of
15 the funds appropriated under sub-paragraph (2) of section 5 of this
16 act shall be the Upper Mortlocks Development Authority. The allottee
17 of the funds appropriated under sub-paragraph (3) of section 5 of this
18 act shall be the Mid-Mortlocks Development Authority. The allottee of
19 the funds appropriated under sub-paragraph (1) and subsections
20 (4)(a)(ii), (4)(b)(ii), (4)(c)(ii), (4)(d)(ii), and (4)(e) of section
21 6 of this act shall be the Hall Islands Development Authority. The
22 allottee of the funds appropriated under sub-paragraphs (2) and (5) of
23 section 6 of this act shall be the Weito Islands Development
24 Authority. The allottee of the funds appropriated under sub-
25 paragraphs (3) and (6) of section 6 of this act shall be the Pattiw

1 Islands Development Authority. Each allottee shall be responsible for
2 ensuring that these funds, or so much thereof as may be necessary, are
3 used solely for the purposes specified in this act, and that no
4 obligations are incurred in excess of the sum appropriated. The
5 authority of the allottees to obligate funds appropriated by this
6 act shall not lapse until expended.

7 Section 9. Effective date. This act shall become law upon
8 approval by the President of the Federated States of Micronesia or
9 upon its becoming law without such approval.
