FOURTH REGULAR SESSION, 1988 CONGRESSIONAL BILL NO. 5-402, C.D.1, C.D.2

AN ACT

To appropriate the sum of \$150,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1989, for the purpose of funding certain development projects in the State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$150,000, or so much thereof as may be
- 2 necessary, is hereby appropriated from the General Fund of the
- 3 Federated States of Micronesia for the fiscal year ending September
- 4 30, 1989, for the purpose of funding certain development projects in
- 5 the State of Pohnpei. The funds appropriated by this act shall be
- 6 deemed to have come from the capital account of the Compact of Free
- 7 Association.
- 8 Section 2. The funds appropriated under section 1 of this act
- 9 shall be apportioned as follows:
- 10 (1) Iohl Road\$ 100,000
- 11 (2) Road development in Kitti 25,000
- 12 (3) Road development in Madolenihmw 25,000
- Section 3. All funds appropriated by this act shall be allotted,
- 14 managed, administered, and accounted for in accordance with applicable
- 15 law, including, but not limited to, the Financial Management Act of
- 16 1979. The allottee for the funds appropriated under subsection (1) of
- 17 section 2 of this act shall be the Community Action Agency of the
- 18 State of Pohnpei. The allottee for the funds appropriated under
- 19 subsection (2) of section 2 of this act shall be the Lukenmoanlap
- 20 (Chief Magistrate) of Kitti Municipality. The allottee for the funds
- 21 appropriated under subsection (3) of section 2 of this act shall be
- 22 the Meninkeder Lapalap (Chief Magistrate) of Madolenihmw

1	Municipality. The allottees shall be responsible for ensuring that
2	these funds, or so much thereof as may be necessary, are used solely
3	for the purposes specified in this act, and that no obligations are
4	incurred in excess of the sum appropriated. The authority of the
5	allottees to obligate funds appropriated by this act shall not lapse
6	until expended.
7	Section 4. This act shall become law upon approval by the
8	President of the Federated States of Micronesia or upon its becoming
9	law without such approval.
