

AN ACT

To further amend Public Law No. 5-52, as amended, by further amending sections 2 and 14, as amended by Public Laws Nos. 5-83, 5-102, 5-106, 5-124 and 5-127, for the purpose of appropriating the sum of \$420,400 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1989, as supplemental funding for the legislative branch of the National Government; adjusting employment ceilings; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 5-52, as amended by
2 Public Laws Nos. 5-102 and 5-124, is hereby further amended to read
3 as follows:

4 "Section 2. Operating expenses of the legislative branch.

5 The sum of \$2,598,225, or so much thereof as may be
6 necessary, is hereby appropriated from the General Fund
7 of the Federated States of Micronesia for the fiscal
8 year ending September 30, 1989, for the operations of
9 the legislative branch of the National Government of the
10 Federated States of Micronesia during fiscal year 1989.

11 The sum appropriated by this section shall be apportioned
12 as follows:

9 Section 2. Section 14 of Public Law No. 5-52, as amended by
 10 Public Laws Nos. 5-83, 5-106 and 5-127, is hereby further amended to
 11 read as follows:

12 "Section 14. Employment ceilings. Subsection (1) sets
 13 forth the maximum number of positions that may be hired by
 14 branches and agencies of the National Government.


20 (2) The number of positions authorized applies
 21 individually to each of the departments and offices of the
 22 executive and legislative branches, the National judiciary,
 23 the Public Auditor, and to the agencies as provided in
 24 subsection (1) of this section, except that the President
 25 may transfer up to 12 positions between the departments and

1 offices of the executive branch. This authorization of
 2 positions covers all permanent employees and all contract
 3 personnel whose employment extends for 1 year or more. No
 4 funds may be expended for unbudgeted positions."

5 Section 3. This act shall become law upon approval by the
 6 President of the Federated States of Micronesia or upon its becoming
 7 law without such approval.
