To further amend Public Law No. 5-52, as amended, by further amending sections 12 and 13, as amended by Public Laws Nos. 5-73, 5-90, 5-110, 5-127, and 6-4, for the purpose of correcting the allocation of certain funds, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. Section 12 of Public Law No. 5-52, as amended by

11	States of Micronesia during fiscal year 1989. The sum
12	appropriated by this section shall be apportioned as follows:
