## AN ACT

To appropriate the sum of \$2,500,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, for the purpose of constructing airports in, and for the purchase and operation of aircraft for, the outer islands of Pohnpei and Truk States and the outer islands of the Federated States of Micronesia as a whole, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: Section 1. <u>Outer islands of Pohnpei and Truk States</u>. The sum of \$1,500,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, for the purpose of constructing airports in, and for the purchase and operation of aircraft for, the outer islands of Pohnpei and Truk States.

8 Section 2. The sum appropriated under section 1 of this act 9 shall be apportioned as follows:

1	funds appropriated under this section for this capital project of the.
2	National Government of the Federated States of Micronesia shall be
-3	deemed to come from the Investment Development Fund.
4	Section 4. All funds appropriated by this act shall be
5	allotted, managed, administered, and accounted for in accordance with
6	applicable law, including, but not limited to, the Financial
7	Management Act of 1979. The allottee shall be responsible for
8	ensuring that these funds, or so much thereof as may be necessary,
9	are used solely for the purposes specified in this act, and that no
10	obligations are incurred in excess of the sum appropriated. The
11	authority of the allottee to obligate funds appropriated by this act
12	shall lapse as of September 30, 1990.
13	Section 5. This act shall become law upon approval by the
14	President of the Federated States of Micronesia or upon its becoming
15	law without such approval.
