AN ACT

To appropriate the sum of \$2,200,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, for the purpose of funding statewide and other public projects in Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Statewide public projects. The sum of \$200,000, or
- 2 so much thereof as may be necessary, is hereby appropriated from the
- 3 General Fund of the Federated States of Micronesia for the fiscal
- 4 year ending September 30, 1990, for the purpose of funding certain
- 5 statewide public projects in Chuuk State.
- 6 Section 2. Northern Namoneas public projects. The sum of
- 7 \$400,000, or so much thereof as may be necessary, is hereby appro-
- 8 priated from the General Fund of the Federated States of Micronesia
- 9 for the fiscal year ending September 30, 1990, for the purpose of
- 10 funding certain public projects in Northern Namoneas, Chuuk State.
- 11 The sum appropriated by this section shall be apportioned as follows:
- 12 (1) Economic and social projects \$400,000
- 13 Section 3. Southern Namoneas public projects. The sum of
- 14 \$460,000, or so much thereof as may be necessary, is hereby appro-
- 15 priated from the General Fund of the Federated States of Micronesia
- 16 for the fiscal year ending September 30, 1990, for the purpose of
- 17 funding certain public projects in Southern Namoneas, Chuuk State.
- 18 The sum appropriated by this section shall be apportioned as follows:
- 19 (1) Economic and social projects \$460,000
- 20 Section 4. Faichuk public projects. The sum of \$500,000, or
- 21 so much thereof as may be necessary, is hereby appropriated from the
- 22 General Fund of the Federated States of Micronesia for the fiscal

1	year ending September 30, 1990, for the purpose of funding certain
2	public projects in Faichuk, Chuuk State. The sum appropriated by
3	this section shall be apportioned as follows:
4	(1) Economic and social projects \$500,000
5	Section 5. Mortlocks public projects. The sum of \$400,000, or
6	so much thereof as may be necessary, is hereby appropriated from the
7	General Fund of the Federated States of Micronesia for the fiscal
8	year ending September 30, 1990, for the purpose of funding certain
9	public projects in the Mortlocks Islands, Chuuk State. The sum
10	appropriated by this section shall be apportioned as follows:
11	(1) Economic and social projects \$400,000
12	Section 6. Pattiw, Weito, and Hall Islands public projects.
13	The sum of \$240,000, or so much thereof as may be necessary, is
14	hereby appropriated from the General Fund of the Federated States of
15	Micronesia for the fiscal year ending September 30, 1990, for the
16	purpose of funding certain public projects in the Pattiw, Weito, and
17	Hall Islands, Chuuk State. The sum appropriated by this section
18	shall be apportioned as follows:
19	(1) Economic and social projects \$240,000
20	Section 7. Allotment and management of funds and lapse date.
21	All funds appropriated by this act shall be allotted, managed,
22	administered, and accounted for in accordance with applicable
23	law, including, but not limited to, the Financial Management Act
24	of 1979. The allottee shall be the President of the Federated States
25	of Micronesia who shall be responsible for ensuring that these funds,

T	or so much thereof as may be necessary, are used solely for the
2	purposes specified in this act, and that no obligations are incurred
3	in excess of the sum appropriated. The authority of the allottee to
4	obligate funds appropriated by this act shall not lapse until
5	expended.
6	Section 8. Effective date. This act shall become law upon
7	approval by the President of the Federated States of Micronesia or
8	upon its becoming law without such approval.
