SIXTH CONGRESS OF THE FEDERATED STATES OF MICRONESIA

FOURTH REGULAR SESSION, 1990

CONGRESSIONAL BILL No. 6-307

AN ACT

To further amend Public Law No. 6-49, as amended by Public Law No. 6-55, by further amending section 5, as amended by Public Law No. 6-55, Chuuk State public projects, to modify the use of funds appropriated thereunder, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 6-49, as amended by
2 Public Law No. 6-55, is hereby further amended to read as follows:

3 "Section 5. Tonoas public projects. The sum of \$136,000,
4 or so much thereof as may be necessary, is hereby appro-
5 priated from the General Fund of the Federated States of
6 Micronesia for the fiscal year ending September 30, 1990,
7 for the purpose of funding certain public projects in
8 Tonoas, Southern Namoneas, Chuuk State. The sum appro-
9 priated by this section shall be apportioned as follows:

- 10 (1) General public projects
- 11 (a) Charter Day Celebration \$ 5,000
- 12 (b) Youth athletes and schools' sea
13 transportation 5,000
- 14 (2) Kuchuwa public projects
- 15 (a) Meseran sewing project 3,000


