CONGRESSIONAL BILL No. 6-328, C.D.1

AN ACT

To further amend Public Law No. 6-72, as amended by Public Laws Nos. 6-94 and 6-100, by amending section 6 to modify the allottee of funds previously appropriated for education related programs and projects in Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 6-72 is hereby amended to
2 read as follows:

3 "Section 6. All funds appropriated by this act shall be
4 allotted, managed, administered, and accounted for in
5 accordance with applicable law, including, but not limited
6 to, the Financial Management Act of 1979. The allottee for
7 the funds appropriated under section 1(1), sections 5(1)
8 and 5(2) of this act shall be the Governor of Kosrae
9 State. The allottee for the funds appropriated under
10 section 5(3) shall be the Mayor of Lelu. The allottee for
11 the funds appropriated under sections 5(4) and 5(7) of this
12 act shall be the Mayor of Tafunsak. The allottee for the
13 funds appropriated under section 5(5) of this act shall be
14 the Mayor of Malem. The allottee for the funds appro-
15 priated under section 5(6) of this act shall be the Mayor
16 of Utwe. The allottee for the funds appropriated under
17 section 1(2) and section 3 of this act shall be the
18 Governor of Yap State. The allottee for the funds
19 appropriated under section 1(4) and section 4 of this act
20 shall be the Governor of Pohnpei State. The allottee for
21 the funds appropriated under section 1(3) and sections
22 2(2), (3), (4), (5), and (6) of this act shall be the

1 Governor of Chuuk State. The allottee for the funds
2 appropriated under sections 2(1) and 2(8) of this act shall
3 be the Southern Namoneas Development Authority. The
4 allottee for the funds appropriated under section 2(7) of
5 this act shall be the School Board of the Saramen Chuuk
6 Academy. The allottees shall be responsible for ensuring
7 that these funds, or so much thereof as may be necessary,
8 are used solely for the purposes specified in this act, and
9 that no obligations are incurred in excess of the sum
10 appropriated. The authority of the allottees to obligate
11 funds appropriated by this act shall not lapse."

12 Section 2. This act shall become law upon approval by the
13 President of the Federated States of Micronesia or upon its becoming
14 law without such approval.
