### STATUTORY SALARIES SCHEDULE ORDINANCE (AMENDMENT) ORDER ~~1995~~ <sup>2001</sup>

In exercise of the powers conferred by section 4 of the Statutory Salaries Ordinance (Cap. 96A) the Beretitenti acting in accordance with the advice of the Cabinet, hereby makes the following order;

**Citation**  
1. This Order may be cited as the Statutory Salaries Schedule (Amendment) Order 2001.

**Commencement**  
1. Salary shall come into force on 1st January, 2001.  
2. Allowances and Other Privileges shall come into force on 1st July 2001
