This Act may be cited as the Citizenship (Amendment) Act, 2010. 10 **Amendments** 11 Section 2. Section 403 of the Citizenship Act is amended as follows: 12 (1) 13 §403. Citizenship by naturalization; general. 14 (1) A person of full age and full capacity may apply in the prescribed manner to the 15 Cabinet to be naturalized as a citizen. 16 (2) Where, on the application made pursuant to subsection (1) of this Section and as a result of such inquiries (if any) as the Cabinet may cause to be made, the Cabinet is satisfied that 17 the person making the application: 18 (a) was (on the date of the application) and has been, during the period of ten (10) 19 years immediately prior to the date of application, ordinarily resident in the Republic; 20 21 (b) The number of persons, who shall be naturalized as citizens under Section 403 of this Act, shall not exceed ten (10), including dependents, in any one calendar year. 22 23 (c) is domiciled in the Republic: (d) is of good character, based upon available evidence, including the 24

recommendations of the Ministry responsible for the administration of citizenship matters

1	and the local government Council of the community in which he has been resident or
2	intends
3	to reside;
4	(e) unless prevented by physical or mental disability, is able to speak and
5	understand
6	Marshallese sufficiently for normal conversational purposes;
7	(f) has an understanding and respect for the customs and traditions of the
8	Republic;
9	(g) has the means of support for himself and his dependents;
10	(h) has a reasonable knowledge and understanding of the Constitution of the
11	Marshall
12	Islands and the rights, privileges, responsibilities and duties of citizenship;
13	(i) subject to Section 412 of this Chapter, has renounced in the prescribed manner
14	any other citizenship which he may possess; and
15	(j) has taken and subscribed, in the prescribed manner, the prescribed oath of
16	allegiance; then the Cabinet, in its discretion, may grant the application, but otherwise
17	shall
18	refuse it.
19	(k) has taken and passed written test as may be prescribed by the Minister;
20	Section 3. Savings.
21	Nothing in this Act shall be construed as affecting persons who have filed application
22	with the Office of the Attorney General and whose applications are currently pending before the
23	commencement of this Act.

1	Section 4. Effective date.
2	This Act shall take effect on the date of certification in accordance with Article IV of the
3	Constitution and Rules and Procedures of the Nitijela.
