2 3 4 5 6 7	to amend Title 36, Chapter 2, of the Republic of the Marshall Islands Revised Code to implement a record keeping requirement in the Marshall Islands Foreign Investment Business License Act, in order to ensure that all business entities are required to maintain records to a level of detail consistent with the international standard.
8 9 10 11	BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS:
12	Section 1. Short Title
13 14 15 16	This Bill may be cited as the Foreign Investment Business License (Amendment) Act, 2015.
17 18	Section 2. Amendment to the Foreign Investment Business License Act
19 20	(1) The Marshall Islands Foreign Investment Business License Act is hereby amended by
21	inserting a new section as follows:
22	§207A. Requirement for keeping records.
23 24	(1) Accounting records. Every non-citizen granted a foreign investment business
25	license pursuant to this Chapter shall maintain reliable and complete accounting records, to
26	include correct and complete books and records of account. Accounting records must be
27	sufficient to correctly explain all transactions, enable the financial position of the non-citizen to
28	be determined with reasonable accuracy at any time, and allow financial statements to be
29	prepared. Additionally, every non-citizen granted a foreign investment business license pursuant
30	to this Chapter shall keep underlying documentation for accounting records maintained pursuant
31	to this section, such as, but not limited to, invoices and contracts, which shall reflect all sums of

money received and expended and the matters in respect of which the receipt and expenditure
takes place; all sales, purchases, and other transactions; and the assets and liabilities of the noncitizen.

4 (2) *Record of ownership*. Every non-citizen granted a foreign investment business 5 license pursuant to this Chapter shall keep an up-to-date record containing the names and 6 addresses of all owners.

7 Form of records. Any records maintained by a non-citizen in the regular course of (3) its business may be kept on, or be in the form of, punch cards, magnetic tape, photographs, 8 9 microphotographs, or any other information storage device, provided that the records so kept can be converted into clearly legible written form within a reasonable time. Any non-citizen shall so 10 convert any records so kept upon the request of any person entitled to inspect the same. When 11 records are kept in such manner, a clearly legible written form produced from the cards, tapes, 12 photographs, microphotographs, or other information storage device shall be admissible in 13 evidence, and accepted for all other purposes, to the same extent as an original written record of 14 the same information would have been, provided the written form accurately portrays the record. 15

(4) *Retention period.* All records required to be kept, retained, or maintained under this section shall be kept, retained, or maintained for a minimum of five (5) years.

19 (2) The Marshall Islands Foreign Investment Business License Act is hereby amended as20 follows:

21 §208A. Civil Penalty.

1	In addition to the provisions of section 208 and 211 of this Chapter, any person who
2	violates a provision of this Chapter shall be liable to a monetary penalty in an amount not
3	exceeding ten thousand dollars (\$10,000).
4	Section 3. Effective Date
5	This Bill, and all Acts contained herein, shall take effect in accordance with the
6	Constitution and the Rules of Procedures of the Nitijela.
