Short Title. 9 This Act may be cited as the Government Shipping Vessels Maintenance Act, 2011. 10 Section 2. Shipping Vessels Maintenance Fund. 11 (1) There is hereby established a special fund, the Shipping Vessels Maintenance Fund 12 hereinafter refer to as "the Fund". 13 (2) The Fund is a special revenue fund within the National Treasury and under the control 14 and supervision of the Ministry of Finance, which shall provide for its administration in 15 accordance with the Financial Management Act of 1990. 16 (3) For the purpose of this Act, "Government Shipping Vessels" means shipping vessels 17 under the management of the Marshall Islands Shipping Corporations. 18 Section 3. Payments into the Fund. 19 There shall be paid into the Fund: 20 (a) monies appropriated by the Nitijela, or as may be received or become available to the 21 Marshall Islands Shipping Corporation for the purposes of maintenance of shipping 22 vessels; 23 (b) such other monies whether in the form of gifts, grants, donations or otherwise, and 24 25 specifically for the maintenance of shipping vessels.

		(a) repair and maintenance of shipping vessels, including the purchase of spare	
		parts and other requisites needed for such purposes;	
		(b) acquire and purchase safety equipments such as rafts, life jackets, fire	
		extinguishers and such other safety requisites needed on a boat or vessel;	
		(c) survey and classification of ships; and	
		(d) dry-docking.	
Sec	tion 5.	Accounts and Records.	
(1) The Secretary of Finance shall maintain, in accordance with the procedures prescribe			
	by th	e Financial Management Act, proper accounts and records with respect to the Fund	
	and a	any item of property purchased with money from the Fund.	
	(2) T	he accounts shall be laid before the Nitijela by the Minister of Finance pursuant to	
	Artic	le VIII, Section 5 (4) of the Constitution.	
	(3) T	he accounts and records maintained under Subsection (1) of this Section shall be	
	audit	ed by the Auditor General as provided for under Article VIII, Section 15 of the	
	Cons	titution.	
Sec	tion 6.	Effective Date.	
	This	Act shall take effect on the date of certification in accordance with Article IV,	
Sec	tion 21 o	f the Constitution and the Rules of Procedures of the Nitijela.
