persons, unless the defendant knowingly and voluntarily waives the right to a jury

trial. The Republic shall be entitled to two (2) pre-emptory challenges and the

defendant or defendants jointly to two (2) pre-emptory challenges. If there is more

than one defendant, the court may allow the defendants additional peremptory
