14		(1) The primary duty and responsibility of the Department of the Public	
15		Defender shall be to provide, upon request, legal defense assistance and	
16		representation in criminal proceedings to all persons in the Republic who cannot	
17		afford to hire a private attorney.	
18		(2) The secondary duty and responsibility of the Public Defender shall be to	
19		provide, upon request, legal defense assistance and representation in civil actions	
20		to all persons in the Republic who cannot afford to hire a private attorney.

22	(2)	Section 307 of the Marshall Islands Public Defender Act 1979, 5 MIRC Chapter	
23	3, is amended to read as follows:

1	The Chief Public Defender, with the approval of the Cabinet, may by		
2	regulation promulgate a "needs test" to determine if for purposes of Section 303
