Cabinet makes the following Regulations under Section 25 of the Drones Act 2018:

# 1 Citation

These Regulations may be cited as the Drones (Forms and Fees) Regulations 2020.

# 2 Commencement

These Regulations shall commence on the day they are notified in the Gazette.

# 3 Application for permit to import drone

For the purpose of *Section 8* of the Act, an application for a permit to import drone shall be in Form 1 of Schedule 1.

# 4 Application for licence to sell drones

For the purpose of *Section 10* of the Act, an application for a licence to sell drones shall be in Form 2 of Schedule 1.

# 5 Application for permit to use drones

For the purpose of Section 13(1)(a) of the Act, an application for a permit to use drones shall be in Form 3 of Schedule 1.

# 6 Permit to import drones

A permit to import drones shall be in Form 4 of Schedule 1.

# 7 Licence to sell drones

A licence to sell drones shall be in Form 5 of Schedule 1.

# 8 Permit to use drones

A permit to use drones shall be in Form 6 of Schedule 1.

# 9 Permit or licence not granted to minors

A permit or licence shall not be granted to a person under the age of 18 years.

#### 10 Fees

The fees to be paid for the purposes of the Act and Regulations are set out in Schedule 2.
