## TEXT OF ORDERS AND NOTICES.

## [Order dated 4th January, 1923, and published in New Guinea Gazette of 15th January, 1923.]

#### ORDER PROHIBITING THE RECRUITING OF NATIVES.

In pursuance of section 40 of the Native Labour Ordinances 1922 I, David Sydney Wanliss, Deputy Administrator and the Officer for the time being administering the Government of the Territory do hereby order and proclaim that until further notice from and inclusive of the First day of January, One thousand nine hundred and twenty-three all those areas comprising the following Island Groups and Islands: Ninigo Group, Hermit Group, Allison, Durour, Matty, Anchorite Islands and any other Islands within the boundaries hereinafter described:—

"Commencing at the point of intersection of the 142nd Meridian of East Longitude with the Equator, and bounded thence on the North by part of the Equator bearing East to its intersection with the 146th Meridian of East Longitude and bounded thence on the East by part of that Meridian bearing South to its intersection with the Second Parallel of South Latitude, and bounded thence on the South by part of that Parallel bearing West to its intersection with the 142nd Meridian of East Longitude, and bounded thence on the West by part of that Meridian bearing North to the point of commencement"

shall be prohibited areas for the recruiting of natives within the meaning of the said Ordinance save and except as follows:

Nothing in this Order shall be deemed to prohibit the recruiting or engaging of any male or female native for employment on the aforesaid Island Groups and Islands where such native habitually resides.

And I do hereby order that during such period as aforesaid no person, firm, syndicate, company or the Expropriation Board (nor any employee, representative or recruiter of or for any person, firm, syndicate, company or the Expropriation Board) shall recruit, engage or take any male or female native or natives from the said areas or any part thereof without permission in writing of the Administrator first had and obtained.
