RE-ORGANIZATION OF NATIVE AFFAIRS DEPARTMENT ORDINANCE 1932.⁽¹⁾

No. 24 of 1932.

An Ordinance Relating to the Re-organization of the **Department of Native Affairs.**

BE it ordained by the Governor-General in and over the Com-monwealth of Australia acting with the advice of the Federal monwealth of Australia, acting with the advice of the Federal Executive Council, in pursuance of the powers conferred by the New Guinea Act 1920-1926, as follows :---

1. This Ordinance may be cited as the Re-organization of Native Short title. Affairs Department Ordinance 1932.⁽¹⁾

2. This Ordinance shall be deemed to have commenced on the Commencement. fourteenth day of September, One thousand nine hundred and thirty-two.

3.—(1.) Where, by or under any Ordinance or any regulation Director of made thereunder in force at the commencement of this Ordinance, and Native or by or under any instrument executed under or in pursuance of any such Ordinance or regulation, any power or function is powers of Commissioner exercisable by, or anything is required to be done by, to or before the Commissioner of Native Affairs, that power or function shall be exercisable by, and may be done by, to or before the Director of District Services and Native Affairs, and any reference to the Commissioner of Native Affairs in any such Ordinance, regulation or instrument shall be read as a reference to the Director of District Services and Native Affairs.

(2.) Where any such power or function has been exercised by, or any such thing has been done by, to or before the Commissioner of Native Affairs on or after the fourteenth day of September, One thousand nine hundred and thirty-two, that power or function shall be deemed to have been lawfully exercised by, and such thing shall be deemed to have been lawfully done by, to or before the Director of District Services and Native Affairs.

Rights of Commissioner of Native Affairs in respect of land.

4.—(1.) Any right, privilege, obligation or liability in, over or in respect of land acquired, accrued or incurred by the Commissioner of Native Affairs shall pass to and be held by the Director of District Services and Native Affairs.

(2.) Where any land is registered under the Lands Registration Ordinance $1924-1931^{(2)}$ in the name of the Commissioner of Native Affairs, the Registrar appointed under that Ordinance shall substitute the name of the Director of District Services and Native Affairs for that of the Commissioner of Native Affairs in the register and in any instrument relating to that land.
