Additional Supplementary (Appropriation) Act 2008,

Being an Act to grant and apply out of the Consolidated Revenue Fund a further additional sum for expenditure for the year ending 31 December 2008 and to appropriate that sum,

MADE by the National Parliament.

1. GRANT OF K 850,000,000.00.

- (1) Subject to authorization from the Minister, the Secretary for Treasury may issue out of the Consolidated Revenue Fund and apply for Additional Expenditure for the year ending 31 December 2008 the sum of K595,000,000.00.
- (2) Subject to the conditions set out in Section 5 of this Act, the Minister may provide authorization for the Secretary for Treasury to issue out of the Consolidated Revenue Fund and apply for Repayment of Government Liabilities for the year ending 31 December 2008 a further sum of K255,000,000.00.

2. APPROPRIATION.

Sums granted by this Act out of the Consolidated Revenue Fund for Additional Expenditure and Repayment of Government Liabilities for the year ending 31 December 2008 are appropriated for the approved purposes to be implemented by Agencies expressed in Schedule 1.

3. ADJUSTMENT OF APPROPRIATION BETWEEN SERVICES.

Where there is insufficient or no appropriation to meet expenditure for a particular service, the Secretary for Treasury may direct the re-allocation of any unexpended appropriation under this Act through the Secretary's Advance, provided that doing so does not contravene the directions contained in Sections 4 and 5 of this Act.

Additional Supplementary (Appropriation)

4. DIRECTION FOR ADDITIONAL EXPENDITURE.

- (1) Subject to this section, K250.5 million of the amount appropriated to Division 207 must be immediately transferred from Division 207 to trust accounts identified for the approved purposes expressed in Schedule 2 in order that the sums can be paid into trust accounts under Section 16 of the *Public Finances (Management) Act* 1995.
- (2) Where a trust account specified in Schedule 2 does not exist, a new trust account must be established by the Minister for Finance under Section 15 of the *Public Finances (Management) Act* 1995 and the transfer shall take place immediately on the establishment of the trust account.
- (3) In the event that the amounts expressed in Schedule 2 are not transferred, the appropriation shall lapse and the amounts shall be returned to the Consolidated Revenue Fund and that these funds cannot be utilized or transferred for any other purpose.
- (4) The K250.5 million directed to the Transport Sector Infrastructure Maintenance and Rehabilitation Trust must be used solely for the following purposes in the amounts indicated:

5. DIRECTION FOR REPAYMENT OF GOVERNMENT LIABILITIES.

- (1) Subject to this section, K100 million of the amount appropriated to Division 207 must be paid to Nambawan Super Limited for the purpose of reducing the Government's liability for unfunded superannuation contributions.
- (2) The amount (funds) specified in this section are to be utilized solely for this purpose, and the State must not borrow to fund payment under Division 207.
- (3) K124 million of the amount appropriated to Division 207 must be used for the retirement of public debt and these funds cannot be utilized or transferred for any other purpose.
- (4) K31 million of the amount appropriated to Division 207 is to be paid to Nasfund for the purpose of settling the balance of the State contribution as Reconstruction Grant. These funds cannot be utilized or transferred for any other purpose.
