Short Title. and Commencement. 1. This Appropriation shall be entitled the Choiseul Province 1995 - 1996 Appropriation and shall come into force upon approval of the Minister in accordance with Section 32 of Provincial Government Act 1981 and publication in the Solomon Islands Gazette.

Authorisation of issue of \$4,357,455 from the Provincial Fund.

2.. The appropriation from the Provincial Fund is hereby authorised of a sum of FOUR MILLION THREE HUNDRED AND FIFTY SEVEN THOUSAND FOUR HUNDRED AND FIFTY FIVE DOLLARS to be applied for purposes specified in Section 36 (2) of the Provincial Government Act, and to the services of the financial year ending 31st March, 1996.

Appropriation.

3. The sum specified in the preceding Section shall be appropriated for the supply of the heads specified and in the amounts respectively specified in relation thereto in the schedule of this Appropriation.

Contingencies Warrants.

- 4. The total of the sum authorised by Contingencies Warrants issued by the Premier in exercise of his powers under Section 26 of 27 of the Choiseul Province Financial Management Ordinance 1992 for the financial year ending 31st March, 1996 shall not exceed:
 - (a) in repect of Heads of Recurrent Expenditure Twently Thousand dollars;
 - (b) in respect of Heads of Capital Expenditure Thirty Thousand dollars.

Advances

5. The total of the sums authorised by advances warrants issued by the Premier in exercise of this powers under Section 43 of the Choiseul Province Financial year ending 31st March, 1996 shall not at anytime exceed Ten Thousand dollars.
