IN THE MATTER OF MAGISTRATE SALESI MAFI

AND

IN THE MATTER OF SECTION 11(4) OF THE MAGISTRATE'S COURT ACT

ORDER

IN EXERCISE of the powers conferred upon me by section 11(4) of the Magistrates Court Act I hereby invest Salesi Mafi, Acting Chief Magistrate, with the power to hear and determine, with the consent of the prosecution and the defendant, and in accordance with sections 35 or 36 of the Act, criminal cases where the maximum punishment imposed will not exceed seven years imprisonment or a fine of \$50,000.

The power hereby invested shall, unless beforehand renewed, expire 12 months from the date hereof.
