## ORDER-IN-COUNCIL

### LAND ACT (CAP. 132) (Section 98(2))

**IN EXERCISE** of the powers conferred by section 98(2) of the Land Act (Cap. 132) as amended, His Majesty in Council, hereby specifies by this Order-in-Council that the:

#### NATIONAL RESERVE BANK OF TONGA of Salote Road, Nuku'alofa

being a body corporate established under the National Reserve Bank of Tonga Act (Cap. 102), as amended, shall be authorised to accept only mortgages by its employees solely in respect of residential house loans and to enjoy and accept the rights, privileges, duties and responsibilities of a mortgagee therein under the Land Act (Cap. 132) as amended.
