CONSUMPTION TAX ACT 2003 (Section 5(3)(a))

ORDER

IN EXERCISE of the powers conferred by section 5(3)(a) of the Consumption Tax Act 2003, the Minister of Revenue and Customs, with the approval of Cabinet, makes the following Order:

1. That the materials imported for the renovation of Loumaile Hotel and Black Pearl Suites as certified by the Ministry of Revenue and Customs and listed in Schedule 1 be exempted from consumption tax.
2. That the exemption shall only apply for a period of two months from the date this Order is gazetted.
