Majesty, in exercise of the powers conferred upon Her by sections (2)(c) and (3) and 20(2) of the Fugitive Offenders Act 1967(a), is pleased by and with the advice of Her Privy Council, to make the following Order, a craft of which has been laid before Parliament and has been approved by resolution of each House of Parliament:

This Order may be cited as the Fugitive Offenders (United F Tependencies) (Amendment) Order 1976 and shall come into operation on 16th Secember 1976.

The words "Brunei" and "The Government of Brunei" shall be omitted From the Schedule to the Order of 1968. 6. For the words "Her Majesty's High Commissioner for the Western Parific or the Resident Commissioner for the New Hebrides acting with his () Sauthority" in the Schedule to the Order of 1968 there shall be substituted the words "The Resident Commissioner in the New Hebrides."
