THE SCHOOL BOARDS OF MANAGEMENT

(ST. PATRICK'S HIGH SCHOOL, VUREAS)

RULES 1975

- 1. These Rules may be cited as the School Boards of Management (St. Patrick's High School, Vureas) Rules 1975.
- 2. The school known as St. Patrick's High School, Vureas (hereinafter referred to as /the school") shall continue to be known by that name,
- The Board shall be known as the St. Patrick's High School, Vureas, Board of Management and shall assume responsibility for the administration of the school on the 1st day of March 1975.
- 4. The school shall provide a three-year course of secondary education and shall enter its pupils for the New Hebrides Leaving Certificate Examination and an other such examinations approved by the Chief Education Officer.
- 5. The Bishop of the New Hebrides shall be deemed for all purposes to be the owner of the school.
- 6. The Board shall be constituted in the manner following -
 - (a) the Bishop of the New Hebrides, who shall be the Chairman;
 - (b) one member nominated by the Bishop of the New Hebrides;
 - (c) three members to represent the parents of the students attending the school from different islands within the Group, subject to the approval of the Bishop of the New Hebrides;
 - (d) one member nominated by the staff of the school, subject to the approval of the Bishop of the New Hebrides;
 - (e) the Medical Superintendent of Godden Memorial Hospital, ex officio;
 - (f) the Education Secretary of the Diocese of the New Hebrides, ex officio
 - (g) the Deputy Chief Education Officer, ex officio, or in his absence an officer of the Education Department appointed by the Chief Education Officer.

- 8. Appointments to the teaching staff and ancillary staff of the school including the Headmaster shall be made by the Board in accordance with conditions applying to the staff of the Diocese of the New Hebrides and subject to the approval of the Chief Education Officer.
- 9. Admission of pupils to the school shall be in accordance with minimum educational qualifications presceived by the Chief Education Officer.
- 10. The Board shall fix school fees and remit fees in accordance with principles directed by the Chief Education Officer.

These Rules are made under the powers conferred by ection 4, 12 and 13 of the Education (School Boards of Management) Regulation 1974, this twenty-fourth day of January, 1975.
