#### A JOINT POLICE REGULATION

No. 3 of 1942.

prevent disaffection and disorder among natives and provide for confining disaffected or dangerous natives to particular localities in the New Hebrides.

Issued by the Resident Commissioners under the provisions of Article 8 (3) of the Anglo-French Protocol 1914.

- 1. (1) It shall be lawful for the Resident Commissioners, acting conjointly, by Order under their hands, to confine any native, whom they believe to be disaffected towards the Condominium Government or otherwise dangerous to the peace and good order of the New Hebrides, to a particular locality in the New Hebrides, for any period which may be prescribed in the Order.
- (2) An Order under this section shall be in the form contained in Schedule I hereto, and shall be known as a confining Order.

In this Regulation a native means any person defined as a native in Article 8 (1) of the abovementioned Protocol.

- 2. (1) It shall be lawful for the Resident Commissioners, acting conjointly (immediately when, or at any time after a confining order has been made against a native), to issue a warrant under their hands for the arrest of such native, and for his removal in custody to the particular locality to which, by the terms of such Order, he is to be confined.
- (2) Such warrant shall be in the form contained in Schedule II hereto.
- 3. On the arrest of a native against whom a confining order has been made and his arrival at the particular locality to which, by the terms of the Order, he is to be confined, he shall be delivered over to the District Agent, and a copy of such confining order shall be given to such District Agent.
- 4. Immediately thereafter, the native against whom such confining order has been made, shall, after the contents of the said order have been duly communicated to him, be set at liberty by the District Agent in such locality, and he shall thenceforth, with the exception that he may not go outside the limits of such locality, and shall continue to keep the peace and be of good behaviour, be subject to no other restrictions under the confining order.
- 5. Any native against whom a confining order has been made who, being in, or having been delivered over to the District Agent in, the particular district in which he is to be confined, shall, after the

onfining order has been duly communicated to him and during the eriod the said order is in force—

- (a) fail to keep the peace and be of good behaviour, or
- (b) go outside the limit of such locality,

hall be guilty of an offence, and, on conviction thereof by a native court having jurisdiction in the area of his confinement, shall be liable to imprisonment for any time not exceeding one year.

- 6. The Resident Commissioners, acting conjointly, may at any time, by Order under their hands revoke or modify any confining order.
- 7. This Joint Regulation may be cited as the "Disaffected Natives Joint Police Regulation 1942" and shall come into operation on the day of the date hereof.
