## JOINT REGULATION

No. 26  
of 1971.

To provide for a flat rate sanitation charge.

MADE by the Resident Commissioners under the provisions of paragraph 2 of Article 2, Article 5 and Article 7 of the Anglo-French Protocol of 1914.

1. [(1) A quarterly sanitation charge shall be payable in Vila and Santo in the months of January, April, July and October in each year—

- (a) by every consumer of water who is required to obtain a business licence under the provisions of the Business Licences Joint Regulation of 1956 as from time to time amended, or any joint regulation amending or replacing the same, at the rate of 750 FNH or the equivalent thereof in Australian dollars at the official rate of exchange per quarter;
- (b) by every other consumer of water, at the rate of 550 FNH or the equivalent thereof in Australian dollars at the official rate of exchange per quarter.]

(2) The Charge shall be included as a separate item in the water account of each consumer and shall be payable at the Condominium Treasury at Vila and at the Customs Office at Santo, within one month of the receipt of the account.

2. In this Regulation unless the context otherwise requires—  
“Consumer” means a person in occupation of any premises to which a water supply pipe and meter have been laid. “Water account” means the water account issued under the provisions of the Water Supply Joint Regulation 1955. “Vila” and “Santo” shall mean those areas of Vila and Santo in which there is a sanitary collection.

3. Any person who fails to pay his sanitation charge within the period of one month permitted under section 1 shall be liable to a fine not exceeding £A50 or its equivalent in francs at the current rate of exchange.

Penalty.

4. Joint Regulation No. 28 of 1964, Joint Rules No. 10 of 1964, Joint Sanitation Charge (Amendment) Regulation No. 3 of 1968 and Joint Sanitation Charge (Amendment) (No. 2) Regulation No. 14 of 1968 are hereby repealed.

5. This Regulation may be cited as the Joint Sanitation Charge Regulation No. 26 of 1971 and shall come into operation on the 1st day of January, 1972.
