JOINT REGULATION

535

To create a Town-Planning Commission at Vila.

[Joint Regulation No. 6 of 1954 was published in Condominium Gazette No. 183 and is reprinted as amended by Joint Regulation No. 13 of 1965 (Condominium Gazette No. 213).]

Made by Her Britannic Majesty's Resident Commissioner and the Resident Commissioner for the French Republic under the provisions of the Anglo-French Protocol of 1914.

[1. (1) There is hereby established at Vila a Town Planning Commission constituted as follows—

The French and British District Agents or their Representatives:	Co-Chairmen
The British Senior Medical Officer or his Representative:	Member
The Condominium Superintendent of Public Works or his Representative:	Member
The Head of the Survey Department or his Representative:	Member
An unofficial member chosen annually by the French District Agent from amongst French citizens and dependents:	Member
An unofficial member chosen annually by the British District Agent from amongst British subjects and dependents:	Member

A New Hebridean member chosen annually by the District Agents acting jointly:

(2) The Resident Commissioners may, by Joint Decision, nominate any additional member.

(3) A quorum of the Commission shall be constituted by the presence of not less than half its members.]

2. The Town Planning Commission shall exercise the powers heretofore devolved upon the "Sanitary Commission" by Joint Regulation No. 6 of 1931, and those conferred upon the Town Planning Commission by the letter No. 59 RB/CH of the 9th February, 1952 (formulation of the Town-planning policy).

3. The Commission shall particularly be required to examine applications made to the Resident Commissioners for permission to build or make repairs within the urban area from town-planning, technical and sanitary points of view. It shall give to the Resident Commissioners reasoned opinions for the decision made regarding Joint Regulations

any application under consideration; which application shall be accompanied by a plan of the site proposed, a scaled ground plan and a scaled front and side elevation plan of the projected construction or repair.

4. The Commission shall be entitled, where it is found necessary, to ask the assistance of the Joint Court interpreter.

5. The British and French Assistant Resident Commissioners, the British and French Commandants of Police, are charged, inasmuch as they are severally affected, with the execution of this Regulation, which shall be cited as the Town-Planning Commission regulation of 1954, and shall be published wherever it is necessary so to do.
